

In response (synopsis) with suggestions to the CNN Town Hall Meeting "City in Crisis" in Minneapolis
1/28/26

1. Lose the masks and use personal ID tags and vehicle identification tags
2. Wear body cameras
3. Must get subpoenas
4. No more "No Knock" entry
5. No more random pushing or any physical contact with citizens or people
6. Must have the appropriate warrant with specific reason to make contact (verbal or physical) with reason to suspect the person of being at the site of contact
7. ICE must get appropriate training for crowd control and restrict use of a. pepper spray, b. bean bags, c. gas or the like, and d. any like lethal munitions.
8. No use of guns, use Tasers No aiming or discharge into chest or head, use only under extreme defensive conditions
 - a. Need a complete turnover of all ice agents that go to different cities as they seem to be experiencing burn out.
9. ICE agents must notify local police before contact with any suspects.
10. Any ICE Agents or Boarder Patrol involved in use of any restraint tactics will report to the appropriate evaluator for "time out" of no less than 3 days for incident review before returning to street assignment.
11. Ending search for "illegal" immigrants: one must present and receive an official warrant for at least one individual in a week's time in any specific district. Failure to do so will immediately result in termination of all ICE activity in that district.
12. Issue: No stopping people randomly to ask for ID as a means of finding an "illegal alien". An agent must have a search or questioning certified warrant for a specific individual before making contact with any individual.
13. No random removal of any individual without presentation of a certified letter from a magistrate.
14. When, as a result of having publicly announced a declaration of finding that action is found to be chargeable, wrong or false, then this finding shall be publicly disclosed with an apology. Otherwise, all agents must leave the district.
15. There must be individual teams of no more than 4 people who process warrants, who will have an individual supervisor/evaluator assigned fresh on a daily basis to evaluate any engagement between agents and citizens.
16. Supervisors having been issued a "Storm" whistle will use the "storm" whistle to call a time out of any and all activity as necessary. Upon hearing the "Storm" whistle, the ICE team member will stop ALL activity immediately regardless of activity except those providing emergency medical care. Otherwise, activity can only resume when and if the supervisor so instructs.

Comments/Questions

17. Should ICE Agents and city police practice Team Tactics individually and together for crowd or engagement situations.
18. Question- should we mingle those two groups (e.g. break bread together)?

19. No quotas as Police say that quotas just add to the fear in their experience.
20. Practice how to respond to thrown bottles, rocks, or ice being thrown. Must slow things down and de-escalate.
21. Need to discuss among the Town Hall participants about the entire situation in Town Hall meetings so that they know the helpful role that the city police are playing. This will keep their support up.
22. Need the President and all leaders from both sides to stop the negativity. They set the tone.
23. Can people still exercise their 2nd amendment rights in one of the confrontations?
24. Gun holders need to act conservatively and judiciously in their display of a gun, same with cell phones.
25. The overall sense/feeling from the audience was that ICE and all their tactics must leave Minnesota. Fear prevails.
